Pursuant to Revenue and Taxation Code §100.06(c)(4)(A), the County Auditor-Controller is required to provide the enclosed report by May 15, 2010 regarding your local agency's mandatory loan to the State. This letter will also be posted on the Auditor-Controller's website.

The County Auditor-Controller is also required to report to each local agency the details of the calculations by January 15, 2010. This task was completed on 9/15/09. This information is also posted on the Auditor-Controller's website at

As a reminder, the first half of your local agency's amount was actually deducted on April 23, 2010 from current year secured taxes and transferred (via JE) into the required Supplemental Revenue Augmentation Fund (SRAF) which is controlled by the Office of Education. In early June, your local agency will receive a JE for any county treasury pooled interest earnings lost from April 23, 2010 through May 2, 2010.
