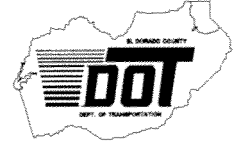

5.04	Plan Sheet 354	Project Plan Sheet 354 - "SUMMARY OF QUANTITIES Q-1" is revised to change the quantities for "Roadway Excavation", "Embankment", "Rock Excavation", and "Hot Mix Asphalt".
5.05	Plan Sheet 356	Project Plan Sheet 356 - "SUMMARY OF QUANTITIES Q-3" is revised to change the quantity for "Remove Curb".


