1	SP-6	<p>Question: On page SP-6 of the Special Provisions for the US 50/Missouri Flat Road Phase 1 B project under section 2-1.054 Required Listing of Proposed Subcontractors. The last paragraph states that “Forms for listing the subcontractors who will work on this Project as well as subcontractors who have submitted quotes or bids, but were not selected to work on this Project are included in the Proposal section of these Contract Documents. Our Contract Documents do not seem to contain any documents for listing subcontractors who were not selected for this project. Can you please clarify if this document is included in the original package given to bidders?</p> <p>Maybe our package is missed the copy of this form?</p> <p>Answer: Section 2-.105 “Required Listing of Proposed Subcontractors” Revise the last sentence of this section to read as follows: <i>“Forms for listing the subcontractors who will work on this Project are included in the Proposal section of these Contract Documents.”</i></p>

Since this change is not a “material change” as defined in Section 4104.5(b) of the Public Contract Code, the bid opening date remains Wednesday, October 21, 2009.

This addendum shall be attached to the contract documents booklet.
