It is also acceptable to copy the Bidder's Bond form, execute it, and attach the executed form to the original Bidder's Bond form by staples or other means.
2.	Bidder's Bond Notary Acknowledgment	Question: What is the purpose of the form immediately following the Bidder's Bond?
	Form	Answer: The note at the bottom of the Bidder's Bond states that the signature of those executing for the Surety shall be properly acknowledged and accompanied by a Certificate of Acknowledgment. The form immediately following the Bidder's Bond form is the Certificate of Acknowledgment to be completed on behalf of those executing for the Surety.
3.	SP-3	Question: Are we required to return the entire Contract Document Booklet with our bid? Answer: Yes
4.	C-1 through C-9,	Question: Do I need to complete the contract as part of my bid proposal? Answer: No, the contract is provided as a sample only.
5.	P-1 through P-10 & Bidder's Bond	Question: Am I correct that I need only complete pages P-1 through P-10 and the Bidder's Bond?
	D 40	Answer: Yes.
6.	P-10	Question: P-10 states that a copy of the afore-referenced license must be attached hereto. What constitutes a copy of the license?
		Answer: A copy of the license card issued by the Contractors State License Board is acceptable.
