

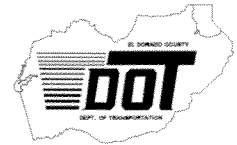

9.01	TH plan sheets	<p>Question: Will MBGR be required to be installed by phase or after installation of the final 2" overlay (Ph 3)?</p> <p>Answer: See Addendum No.5</p>
9.02	SP-50	<p>Question: Can you confirm that the Contractor is to only remove and disconnect, but not reinstall the electric gate at APN 069-241-14 per section 5-1.47?</p> <p>Answer: Yes. The Contractor is only to disconnect and remove the electric gate at APN 069-241-14.</p>
9.03		<p>Question: Is the site accessible to perform a site visit?</p> <p>Answer: Yes</p>
9.04		<p>Question: Where can I find the County's Standard Specifications for Landscaping referenced in spec book?</p> <p>Answer: The Standard Specifications that are referenced are Caltrans.</p>
9.05		<p>Question: With regards to the Stage 2 work, can the County share their estimated quantities for road excavation, AB & AC?</p> <p>Also, does the County have a breakdown of the structure excavation and backfill (final pay) items?</p> <p>Answer: The County can not share this information.</p>
9.06	N-5	<p>Question: We have not received addenda or inquiry responses in the mail. Is this correct?</p> <p>If so, can I assume that both of these are to be taken off your website for this project? Are executed addenda downloaded from the website considered acceptable?</p> <p>Answer: Attention is directed to the PROJECT ADMINISTRATION section of the Notice to Bidders.</p>

9.07	N-5 and SP-46	Question: Where can I find a copy of the soils report? Answer: The Foundation Investigation Report and associated addenda can be found at our website http://www.edcgov.us/Government/DOT/Bids.aspx
9.08	SP-154	Question: In addendum #3 under "Develop Water Supply" it talks about a "Temporary Connection". Would the location of the temporary connection be on the site? Is the Hydrant at the corner of Oakvale Drive and Green Valley Road available for Construction Water? Answer: See Addendum No. 5
