Section 72 of the Caltrans Standard Specifications does not specify rock sizes.</p> <p>Answer: Bidder's attention is directed to Special Provisions page SP-92 of the Contract Documents related to the rock grading restrictions.</p> <p>As specified in Special Provisions Section 10-1.21 of the Contract Documents:</p> <p><i>"This Section 10-1.21, "Rock Specifications," shall replace Section 72, "Slope Protection," of the Standard Specifications."</i></p>
