

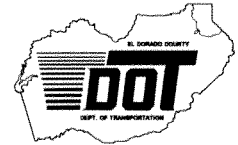

2.01	SP-79 PCMS	Question: Please define (SWD) Sign Working Days. Answer: Please see the first paragraph of the Measurement and Payment clause for PCMS on SP-79
2.02		Question: Will the County provide construction staking? Answer: See Section 5-1.07 of the Amendments to the Standard Specifications in Appendix A.
2.03	Appendix C	Question: When setting PCMS on Highway 50 will traffic control or K-rail be required. Answer: Contractor shall follow all the requirements, including safety requirements, of the Caltrans Encroachment permit obtained by the County and attached to Contract Documents as Appendix C. Contractor shall obtain a Caltrans Encroachment Permit and comply with all pertinent conditions.
2.04	10-1.04 Dust Control	Question: Has Naturally Occurring Asbestos been discovered on the site? Answer: See Addendum No. 2.
2.05	2-1.06 Disadvantaged Business Enterprise (DBE)	Question: What is the DBE goal, and will submittal of DBE Good Faith Effort paperwork be required? Answer: There is no DBE goal for this project since it is not FHWA funded. Submission of DBE paperwork is not required. Bidders are however required to take all necessary affirmative steps to assure that minority firms, women's business enterprises and labor surplus area firms are used when possible.
