Is this correct?  Answer: Yes. The Contractor may propose other vehicular access points as part of the Contractor's proposed Traffic Control Plan submittal subject to County's approval. In addition, per Special Provisions Section 10-1.04 of the Contract Documents,
	(page SP-72)	"The Traffic Control Plan shown on Sheet T-1 of the Plans has been prepared as a guide to Contractor in preparation of a complete Traffic Control Plan and to aid in Contractor's planning for staging/storage of materials and equipment. Contractor's Traffic Control Plan shall include detailed controls, including flaggers, lane closures and signs for all Items of road work which will require alteration of existing traffic patterns. Contractor's Traffic Control Plan shall include all signing required on intersecting streets within the area that will require traffic control. Contractor's plan shall address traffic control related to truck traffic associated with the project construction."
