NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION

NOTICE is hereby given that the County of El Dorado, State of California intends to adopt a Mitigated Negative Declaration for the project described below.

TITLE: Oak Hill Road at Squaw Hollow Creek Bridge (No. 25C0096) Replacement Project (County CIP #77134)

LOCATION: The Project is located approximately 0.6 mile south of Pleasant Valley Road and 5 miles south of Placerville in unincorporated El Dorado County.

APN: County road right-of-way and APNs 098-140-07, 098-140-11, 098-140-13, 098-140-10, 098-180-16, 098-180-70, and 098-180-54.

GENERAL DESCRIPTION: El Dorado County Community Development Agency, Transportation Division, in conjunction with Caltrans and FHWA, is proposing to: (1) replace the existing, functionally obsolete, 24 feet long, 19.6 feet wide, reinforced concrete deck/girder bridge structure, with a new bridge approximately 32 feet long and 32 feet wide, that meets current standards, and (2) widen the road geometry approaching the bridge from both south-bound and north-bound directions. The existing bridge was determined to be functionally obsolete with a sufficiency rating of 52.7 out of 100. The new bridge would have two 12-foot lanes and two 3-foot shoulders and guardrails. Construction of the new bridge would be implemented in stages, and a temporary lane closure of Oak Hill Road near the bridge would be required during construction. REVIEW: The review period for the Mitigated Negative Declaration begins on January 16, 2017 and ends on February 14, 2017. The Mitigated Negative Declaration may be reviewed at County Transportation offices at 2850 Fairlane Court, Placerville, CA.
