## NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION

NOTICE is hereby given that the County of El Dorado, State of California intends to adopt a Mitigated Negative Declaration for the project described below.

TITLE: El Dorado Trail Extension – Missouri Flat Road to the Town of El Dorado and Missouri Flat Road Bike/Pedestrian Overcrossing Project

**LOCATION:** The Project is located within the Sacramento-Placerville Transportation Corridor from northwest of milepost 143 within the Town of El Dorado just north of Pleasant Valley Road, to east of milepost 144 at Old Depot Road south of Placerville, California.

**GENERAL DESCRIPTION:** El Dorado County Department of Transportation proposes to construct approximately 2.2 miles of an 8-foot wide paved Class 1 multi-use bicycle and pedestrian trail from Missouri Flat Road to the Town of El Dorado. The trail will include at-grade crossings at Blanchard and Forni Roads and an overcrossing structure at Missouri Flat Road.

**REVIEW:** The review period for the Mitigated Negative Declaration begins on October 4, 2017 and ends on November 3, 2017. The Mitigated Negative Declaration may be reviewed at the Department of Transportation offices at 2850 Fairlane Court, Placerville, CA 95667 between 8:00 a.m. and 5:00 p.m., Monday through Friday.
