
Wentworth Springs Campground / Post Pile Grade /

Trail Conditions / Observations: Entered the Rubicon Trail (Trail) from Loon Lake entrance. Traveled from Loon Lake to Wentworth Springs Campground and then to Soup Bowl. From Soup Bowl we traveled back to Loon Lake via Gate Keeper on foot due to equipment issues. There were no vehicles seen on the Trail over the course of the day. We observed some vehicle tracks at all sites except for Post Pile. Most of the BMP's were exposed along with the Trail and were functioning as designed. Due to the warmer temperatures, the Trail was exposed approximately sixty percent with a large portion of Loon Lake no longer frozen with ice for the first time all season. We did not observe the other two sites due to equipment issues.

**County Assessment:** As of this site visit for the conditions observed, the County has determined that the goals of the Saturated Soil Water Quality Protection Plan (SSWQPP) are being met. Observed water levels were low enough to not pose a risk of washing contaminants from the under carriage of vehicles pursuant to the monitoring protocols.

Notes: The Rock Lined Channel (RLC) was exposed through the snow, with snow melt run-off moving in the RLC. The water was properly draining towards the Rock Energy Dissipator (RED) which was no longer covered with snow and functioning as designed.

Notes: The Rock Slope Protection (RSP) was exposed on both sides of the Trail. There was minimal snow melt run-off flowing down the hardened surface of the Trail, which discharges into a Rock Energy Dissipator.
