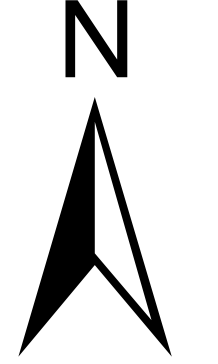


DRAFT PRD Zoning Map for Purpose of Analysis - Detail 2

 This DRAFT PRD Zoning Map is for the purpose of analysis as part of the Environmental Impact Report for the Targeted General Plan Amendment and Comprehensive Zoning Ordinance Update (SC#201202074). No decisions have been made. Final recommendations will be made following a full CEQA review at a public hearing of the Board of Supervisors.
 The zoning presented in this map series is a compilation of Area Plan Zoning Maps and the 1992 Zoning Ordinance.
