The County of El Dorado Zoning Administrator will hold a public hearing in the Building C Hearing Room, 2850 Fairlane Court, Placerville, CA 95667 on January 19, 2022, at 3:00 p.m., to consider the following: Conditional Use Permit CUP20-0005/Saratoga Lane Outdoor Auto Storage submitted by ADAM CROXTON to allow for the construction and operation of an outdoor vehicle storage area with associated sales and rentals. The property, identified by Assessor's Parcel Number 109-213-010, consisting of 1.33 acres, is located on the north side of Saratoga Lane approximately 0.2 mile southeast of the intersection with Robin Lane, in the Cameron Park area, Supervisorial District 2.
