NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the County of El Dorado (“County”) intends to conduct a public hearing on **October 21, 2025, at 1:00 p.m.**, in the Board of Supervisors Meeting Room, 330 Fair Lane, Placerville, CA 95667, to consider adoption of a Resolution Establishing Fees for Film Permits in the County of El Dorado.

The proposed fees are established pursuant to County Ordinance No. 5236 and are intended to recover the reasonable costs of providing County staff and Film Officer services, including the administration, processing, and oversight of filming activities conducted on public and private property within El Dorado County. The fees have been developed in accordance with a Fee Nexus Study, which identifies the relationship between the cost of services and the proposed fee amounts.

All persons interested are invited to attend and be heard or to write their comments to the Clerk of the Board. For the current remote options please check the meeting Agenda no less than 72 hours before the meeting, which will be posted at <https://eldorado.legistar.com/Calendar.aspx>. If you challenge any fees in court, you may be limited to raising only those items you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Board at, or prior to, the public hearing.
