The County of El Dorado Zoning Administrator will hold a public hearing in the **Building C Hearing Room**, 2850 Fairlane Court, Placerville, CA 95667 on **April 1, 2026, at 3:00 p.m.**, to consider the following: **Certificate of Compliance COC-R26-0001/High Sierra Industries** submitted by HIGH SIERRA INDUSTRIES C/O CHRIS MEYER to amend the existing conditions of approval of Conditional Certificate of Compliance COC88-126. The property, identified by Assessor's Parcel Number 331-020-048, consisting of 5.831 acres, is located on the south side of Father Lode Road, approximately 500 feet west of the intersection with Mother Lode Drive, in the El Dorado area, Supervisorial District 4.
