The property, identified by Assessor's Parcel Number 070-180-031, consisting of 29.39 acres, is located on the north side of Meder Road, approximately .07 miles west of the intersection with ~~Sierra Drive~~ Sierrama Drive, in the Shingle Springs Community Region area, Supervisorial District 4.
