We are requesting the support of the Commission to assist this department to fund Department of Veteran Affairs Student Intern Extra Help position utilizing TOT funds, a draft job description and support documentation will be forwarded to the CAO for direction and comment. Chair Kurt Raffetto would like to review the documentation and be advised, at this point, the Commission supports this proposal and awaits CAO comment. David Zelinsky offered that the American Legion Post 119 may be able to financially support this request and will need the support documentation to submit for consideration.

- VA Regional Office: Oakland average claim timeline 1,075 days. VA goal to turn around 125 days, big difference. NOD's are 2 ½ to 3 years minimum, used to be 3 months. Full blown appeals are 1,292 days out; many appeals go to Washington DC and the veteran is typically participates on video teleconference.
