 - Find a different non-profit to manage the funds
 - Volunteer assistance from Commission or Committee.
 - Send funds directly to the recipients.
 - CAO Analyst Creighton Avila to follow up on these mentioned options.
- Review and discussion on how, over the years, Folsom Lake College and Snowline Hospice have spent TOT funds and report the findings to the Board of Supervisors.
 - ❖ Folsom Lake College since 2013 every dollar received has gone to every eligible El Dorado County veteran. The Veterans Resource Center is located at the main campus at Folsom Lake College, the educational center at the El Dorado campus has moved to a larger space and service hours are on Tuesday's between 12-5. These centers are staffed by veterans for veterans and provide a space for veterans to gather, socialize, do homework and form relationships with other veterans. There is a portion of money left this year, however this has been to timing issues such as enrollment dates and when the money has been received; the bulk of the money pays mainly for textbook purchases.
 - Snowline Hospice continues to receive grant funds that supports veterans additional care and their spouse. Social workers now identifying veterans as being in need to provide extra care giving needs that are not covered from Medicare, Medi-Cal and other insurances, our services are designed to fill those gaps.

- David Zelinsky, American Legion Service Officer: Update Veterans Court: Next session is Monday, November 14th at 2:30.

<u>Progress House</u>: It looks like Progress House has volunteer for driving vetrerans around, essentially me. We are working getting applications filled for Veteran Homes and they are all working on their PTSD issues.

<u>Veterans Homes</u>: Redding Veteran Home can take more veterans but cannot hire CAN's because the pay is too low. Yountville has a two year long waiting list, but just one year for homeless Vets. Fresno and Chula Vista will accept Vets with six to nine months of sobriety. Progress House has transitional living and should expect to get six months of certififed sober living for veterans.

<u>PTSD and Suicide</u>: Lots of collaboration, improved communications and improved support from all county resources. We hope to speak with law enforcement and Public Defender how to help identify vets and how to improve on our processes.

<u>TOT Funds</u>: Clarification of unspent funds and services that Folsom Lake College and Snowline Hospice, is there a possible duplication of services from other like-minded charities?

 Social Media Facebook page for the Commission: Scrivani – Legal Disclaimer for Facebook page, still waiting to hear from County Counsel. Tomorrow is the Marine Corps birthday and our Facebook one year anniversary, we are continuing the drive to recruit and involve younger veterans. Discussion to possibly use TOT funds for "boosting" Facebook account, Bill Scrivani will gather information and submit at the next meeting.
