- County Department Veteran Affairs: Minimum staffing during the week of February 22-26, 2016 due the annual training conference in Sacramento. We are planning for future remodel of the current reception area to bring current ADA compliance.

 - El Dorado Community Foundation and the allotment of Funds to Folsom Lake College, verified they receive funds once per year.

- AD HOC (Veteran Memorial Building Veterans Building House Council): Building Manager not available, Bill Schultz reports on the newly installed shed, the service organizations who utilize the building are experiencing growing pains and the shed is a welcome addition. The Veterans Memorial Building is now designated as part of the "Quilt Trail Project" and a patriotic quilt was attached the back of the building, the photograph will be in the local paper soon.
- David Zelinsky, American Legion Service Officer: Update
 Thanks to the Department of Veteran Affairs for assisting a south county veteran who needed a ride to Mather as his thanks for the gesture he has offered room and board for one month to a deserving and eligible veteran.

Veterans Court, seven matters heard, two will transfer to Sacramento. Three were homeless before arrest and will probably be homeless again when released. A local feed store referred a homeless vet, when released this veteran wants to camp, he will need transportation, food, clothes, gear and camping fees. One veteran has limited family support, another has no family support. Two veterans are not homeless but are hard to connect with. Remember, all these veterans are honorably discharged veterans who are eligible for some benefits.

State Veteran Homes, Redding and Fresno are both wait listed, their hiring requirements that CNA's have prior experience, so there are beds but not enough qualified staff. Barstow is short staffed, but has openings. Chula Vista and Lancaster is full and has six month wait list. Yountville has wait list but gives no available time. Unique placement hang ups often occur due to the "No Pets Policy" and unfortunately refusal to take non-disabled residents under 55. West Los Angeles is emphasizing their service mission to homeless Veterans; they are an extreme urban environment in comparison to our rural Veterans.

The Friends of the Veterans Memorial Monument is currently processing IRS reporting documents. Request to invite the president of this group to the next meeting

Meetings are held on the second Thursday of each month at 12:00 noon at the Veterans Memorial Building, which is located at 130 Placerville Drive, Placerville CA."
