#### **COMMISSION MATTERS:**

- TOT (Transient Occupancy Tax) Committee
  - El Dorado Community Foundation has opened the applications for Mini-Grants, you can view and download them on their websites, due at the end of them month. These grants will be reviewed at the October T.O.T. Committee meeting. Adding Amanda Williams to the committee, removing Jack Winhall.
  - O AD HOC (Veteran Memorial Building Veterans Building House Council): Bill Scrivani reported on the City of Placerville Vietnam Veterans Memorial downtown across from the court house, the House Council committed to donate \$14,000 toward this project in collaboration as Eagle Scout project. Apparently, the estimate cost is \$70,000 over and above what the Scout might do. The center piece would be the restoration to a more fitting resting place of the Vietnam Killed In Action bricks that used to be on Main Street. Bud Brown reports that the House Council will financially support a portion of the cost for the re-setting of the bricks.
- David Zelinsky, American Legion Service Officer: Rich Buchanan, for the record, stated that David Zelinsky represents the American Legion.

**ACT Collaborative**: This collaborative is set up by the Cal-Vet, Amador, Calaveras and Tuolumne counties, El Dorado is now part of this organization. The American Legion Post 119 is the host site, meeting is 09/08/2016 at 10:00 a.m.

**Victory Village**: Over the last several months Victory Village has accepted three El Dorado County homeless veterans. Their "yes" has been whole hearted. All three were relatively free of substance issues and mental health issues. I have had only good reports so far.

**State Veterans Homes**: Redding has six empty beds in its memory unit waiting for CAN staffing. Unfortunately, the state still seems to want the CNAs to have worked somewhere else first, which is really screwing up the process. Redding is working with Shasta College to provide CNA training, and HOPES to be allowed to hire the graduates. Filling six beds would make a huge difference in the waiting list. Right now they estimate the wait time for skilled nursing is two years. For the first time they now are full and starting a wait list for RCFE (Residential Care Facility for the Elderly, sort of like Assisted Living).

**Mather Homeless Primary Care**: There has been a huge turnover of staff, which is frustrating. The appointment scheduler is doing a good job of communicating; he let me know that a homeless veteran that I was following failed to get housed because the veteran failed to appear for his TB test, which is a same day chest X-ray. Hopefully, the veteran will be housed by the time of the commission meeting. The new homelessness drug and alcohol worker did a good job getting a homeless female, meth addict, into recovery. Things are on the upswing.

**El Dorado County Jail**: The staff is awesome to work with, they bend over backwards to accommodate access to the veterans. One inmate said he was very pleased with his chaplain. Officer Even of Inmate Services helped an inmate connect to Bible classes, drug and alcohol classes and other behavioral health classes.

**El Dorado County Veteran Affairs:** The staff is supportive in helping connect veterans to local services. The local connection is part of why every veteran needs to connect with their local VSO.

**Veterans Treatment Court**: Once again due to meeting schedule, this report will not reflect the September hearing. A new participant, a female will be sentenced. Connecting her to the VTC staff was a huge win. She will bring up to seven the number of participants. Other incarcerated veterans, hopefully a new protocol will be introduced into our county. It is my hope at the time of arraignment a new form is reviewed with every defendant. Catching the incarcerated veterans in jail, when they are sober and grateful for the attention, is essential.

**Folsom Lake College Veterans Center Programs:** Encouraged the Commission to reconsider funding of this program because other veteran programs could give us more bang for the buck.
