- **RULES** (Smith/Scrivani)
 - By-Laws update Lance Poinsett, review completed by county counsel, final draft to be on next month agenda for final approval; after by-laws will go through new in-house process for Board of Supervisor agenda item.
- **LEGISLATIVE** (Raffetto/Smith) Discussion. In 2004, Veteran Affairs was listed as an endorser; currently we are still awaiting county counsel opinion for Commission endorsement. We believe the Board of Supervisors fully supports this Measure J, possible proposal to endorse a proclamation of good faith and integrity to support the veterans of El Dorado County by this measure. Brian Veerkamp fully intends to hold up its 2004 promise. John Poimiroo will follow up. The intent is to support Measure J, which is an increase to TOT formula, we estimate 12% increase overall.
