- TOT (Transient Occupancy Tax) (Raffetto/Scrivani)
  - Future funding discussion (Raffetto) Budget discussion scheduled for March 3, 2020 and recommendation(s) outcome to continue to the Board of Supervisors. (Moley) reports that HHSA TOT funds distribution and payment processing to recipients is on schedule and going forward, a smoother process.
- **RULES** (Smith/Scrivani) (Poimiroo) reports on that the revised Bylaws have been adopted by the Board of Supervisors and are final (handout).
- **LEGISLATIVE** (Raffetto/Smith) Discussion about extended benefits for Blue Water Navy veterans that served in the territorial waters off Vietnam coast and Agent Orange exposure. Discussion about the MISSION Act which gives vets greater access to healthcare in VA facilities and the community. Big question to ask, how are these changes affecting the veteran? Is there a tracking metric from the VA? Common complaint heard from veterans are: healthcare provider not properly billing the VA; incurred billing debt resulting from out-of-network emergency healthcare, not knowing there is a 72-hour required notice to the VA for coverage. Future meetings, Tim Whalen will prepare a brief for the Commission.
- TRANSPORTATION (Sweatt/Thompson) Receive & file. Still recruiting volunteer drivers.
- BUDGET (Parsons/Poimiroo) No report.

- EDUCATION & EMPLOYMENT (Sweatt/Houseworth) (Christine Wurzer/Brigt Sujerpe) Extended thanks to the Commission for the continued support and recommendations for the TOT funding allocations. Folsom Lake College served 180 veterans at Los Rios campuses, majority attend the Folsom main campus. Key support from experienced staff ensures success in the transition challenge from military active duty to civilian/college student and use of the campus Veterans Success Center. We do lot of different things, we help them with a good education plan, equipment to meet accommodations, textbook grant, parking fee assistance, supplies, emergency relief/assistance, snacks and refreshments. Very helpful for utilizing their educational benefit; we also are a worksite host for the Federal Work Study Program.
