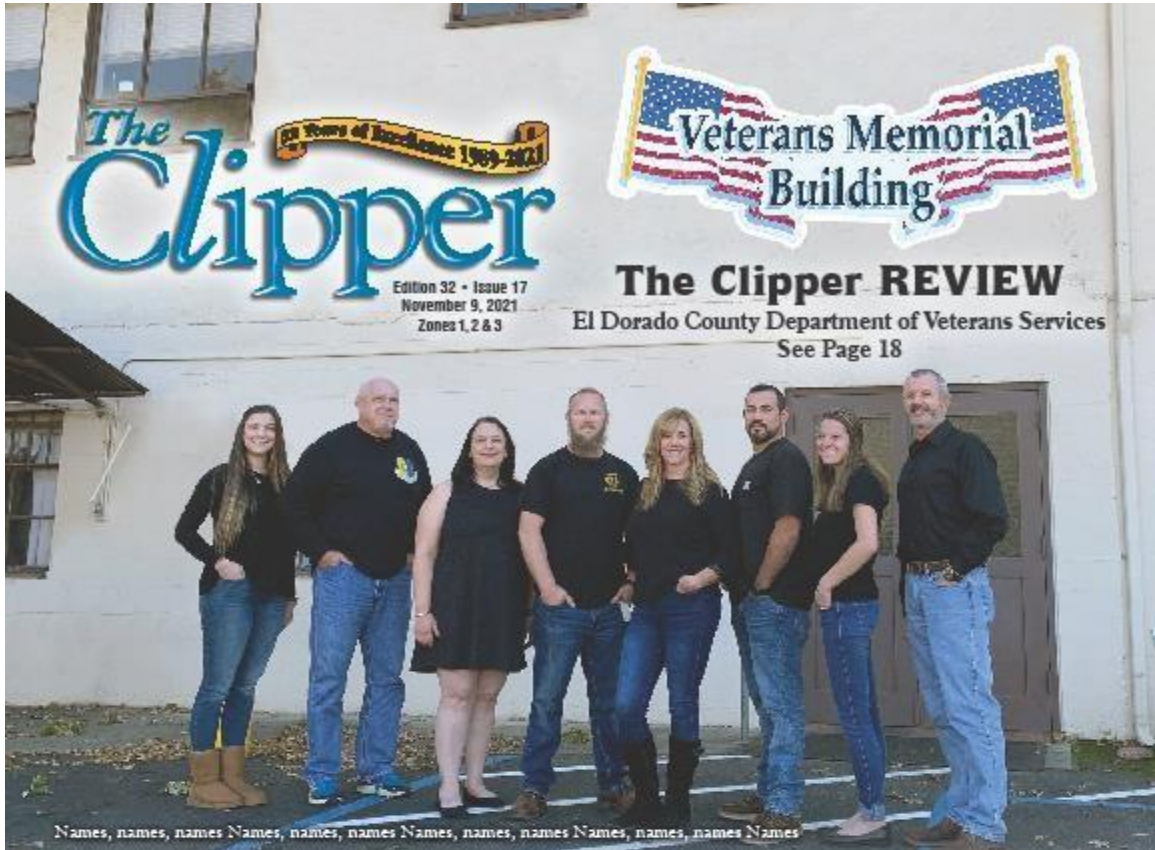

- **SLT Veteran Services Office Update:**
 - Increase Office Hours: If there is an increase in the number of Veterans requesting appointments, we will increase office hours to accommodate the need.
 - Larger and More Signs: The request for exterior signs, is with the sign maker.

We should have the mock-up soon. An interior sign was installed on the window stating the time and days of operation.

- Tahoe Blvd sign: We are researching this request to evaluate the feasibility and cost.
- Red Phone (Hot line): While this item is not being considered at this time, we do offer a phone number to access services five days a week (from 8-5).

- **Veterans Administration Rate Change:**

There will be a **5.9%** increase for VA compensation and pension payments in 2022 due to a cost of living adjustment. Under federal law, the cost-of-living adjustments to VA's compensation and pension rates are the same percentage as for Social Security benefits. Periodically, The Department of Veterans Affairs (VA) makes cost-of-living adjustments (COLAs) to VA compensation and pension benefits to ensure that the purchasing power of VA benefits is not eroded by inflation. Under federal law, the cost-of-living adjustments to VA's compensation and pension rates are the same percentage as for Social Security benefits.

COLAs are determined by an increase in inflation as measured by the Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W). The Bureau of Labor Statistics determined there was a 5.9% increase in 2021. Therefore, the COLA for 2022 is 5.9%.

□ Extension for the Presumptive Period for qualifying Chronic Disabilities:

The Department of Veteran Affairs has extended the presumptive period for qualifying chronic disabilities resulting from undiagnosed illnesses in Persian Gulf War Veterans to December 31, 2026.

Prior to the extension, Persian Gulf War Veterans had to file a claim for disability compensation before the end of the 2021 calendar year. VA is extending the presumptive

period for qualifying chronic disabilities of 10% or more to ensure benefits established by Congress are fairly administered.

With scientific uncertainty remaining as to the cause and time of onset of illnesses suffered by Persian Gulf War Veterans and current research studies are inconclusive, limiting entitlement to benefits due to the expiration of the presumptive period would be premature. If an extension of the current presumptive period was not implemented, Service members whose conditions arise after December 31, 2021, would be substantially disadvantaged compared to Service members whose conditions manifested at an earlier date.

VA presumes certain medically unexplained illnesses are related to Gulf War service without regard to cause. These include: chronic fatigue syndrome, fibromyalgia, functional gastrointestinal disorders, and undiagnosed illnesses with symptoms that may include but are not limited to: abnormal weight loss, cardiovascular disease, muscle and joint pain, headache, menstrual disorders, neurological and psychological problems, skin conditions, respiratory disorders, and sleep disturbances.

A wide variety of symptoms can qualify a Gulf War Veteran for presumptive serviceconnection, Veterans who are experiencing unexplained medical issues are encouraged to file a claim.

□ Identity Theft:

The Federal Trade Commission (FTC) reports that Veterans are especially vulnerable to fraud and identity theft. The FTC recorded more than 41,000 incidents of Veteran fraud and identity theft in 2020.

American Legion Service Officer Report 11/11/21

Some thoughts on homeless shelters.

On the Western slope I have dealt with Mother Teresa House, Hope House, New Morning, New Beginnings, Recovery in Action, U Turn 4 Christ, Tree House Ministries, Center for Non-Violent Relations, Summitview, Progress House, Christ Like Services, Project Room Key in Pollock Pines, Nomadic Shelter, and in Tahoe, a residential recovery program that I believe has since closed, but a couple decades ago I used in juvenile dependency court to save a mom's life, and her parental rights.

All of these programs are very successful on their terms. They filter for who they serve, and have rules.

We serve men only, who will go to church, and engage in compensated work therapy. We will take registered sex offenders, but not if they are convicted under Penal Code Section 288 (the victim was under 14).

We serve pregnant women only, who intend to carry to full term.

We serve women with children only.

We serve underage runaway youth.

We offer residential recovery programs. You have to be willing to be sober.

There are more ways of slicing this up. As you can see, none of these take on all comers. They know what their skill set can handle, and what they can do.

So, who handles all comers? Hangtown Haven's supporters, who are very kind and sweet people, think they had a winner with their encampment. I sat in on meetings with law enforcement who had a completely different take on it. Defecation, alcohol abuse, etc. Not the success their advocates say it was.

The sheriff's department is the premier provider of homelessness services. Yes, the H.O.T. Team is great. Yes. P.E.R.T. is great. Yes, the Crisis Intervention Team is great.

But for an all comers, everyone come on down, the best homeless encampment in El Dorado county?

El Dorado County jail.

Withdrawing from alcohol or heroin? We will give you detox.

Part of a white gang that wants to kill everyone else? We have a separate pod for you.

Registered or accused sex offender, 288 or otherwise? We will administratively segregate you, and protect you from violence, and protect others from you.

Everyone in Placerville wants to beat you up? We will haul you up to Tahoe for custody.

Suffering from psychosis, hearing voices that are telling you to kill your self or others?

Here are some brain meds, and we will watch you in medical.

You are a hard worker and trustworthy? We will give you a job in the kitchen, or as night cat.

You are a woman, and afraid of men raping you? You will be in the women only pod.

You need a walker, and suffer from other medical needs? We have a medical unit.

You would like Bible study, or A.A.? We have it.

You are suffering from mental illness? We have clinicians.

Now, with that experience, EDSO knows how to handle a “we will take everyone” homeless shelter.

As I write this, one homeless Veteran escaped from his Covid motel, and, last I heard, was sleeping in the dirt near Mather. He has called in terrorist threats, held “parties”, broken the rules, etc., at every placement we have found him. He needs to have his civil rights curtailed, and be conserved, but, even then, where does the conservator place him? Soon, probation, will pick him up again, and after a short stint in custody, he will be free to sleep in the dirt again. I still have one idea, involving a Volunteers of America run, VA funded, program, that would give him a place to stay with few rules. But I suspect he will blow that too.

Homelessness cannot be solved by us, because so many of the homeless choose to be homeless. A lovely Veteran was housed in Project Room Key. He is a great candidate for a State Veterans Home, a forever home. But, at the moment, we cannot find the bare land he has chosen to relocate to.

I understand that there may be reasons, financial, legal and contractual that EDSO cannot run the Homeless encampment. If Volunteers of America is hired instead, I would hope that there would be solid collaboration with the experts in housing difficult people, EDSO.

By the way, on the case management meeting that I had to go to while you were all discussing H.O.S.T.E.S.S., Tahoe Coalition for the Homeless announced that someone I will call Murky, had been placed in permanent supportive housing.

Of course, Murky, might decide after winter is over, and the mountains beckon, to sleep in the dirt again.

But tonight, that Purple Heart Veteran, who has been sleeping and living rough for a long time, is warm and fed.
