GUEST SPEAKER - VETERAN SPOTLIGHT – Tim Whelan, Citrus Heights Vet Center and Military Family Support Group Tim Whelan invited to speak by John Poimiroo to discuss his recent efforts during the Caldor Fire emergency. Funding provided by Military Family Support Group/El Dorado Veteran Resources allowed for a spending budget of \$800 per Veteran that required assistance. Tim worked out of the evacuation center located at Green Valley Community Church. A VA nurse from the Chico area went to all the local shelters to see if Veterans required medical help. Tim made contact with 85 Veterans. Spent \$11,288 in hotel stays; 35 Veterans received cash payments between \$100 and \$800; Several hundred dollars given in gift cards; Volunteers of America also assisted Veterans with a grant of \$3,000. Upcoming event "Come and Get It" scheduled for weekend of October 2-3. Will have household goods, appliances, furniture, etc. available.

# <u>Veterans Services – September 2021 Report</u> <u>Richard Todd, Acting Veterans Service Officer</u>

- The Veteran Service Officer recruitment has been posted and is listed as a continuous recruitment until it is filled. I will keep the VAC informed as this process moves forward. The VAC will be participating in the interview process.
- The new Fiscal Assistant, Savanah Dominikus will be starting on September 13.
- Interviews for the Veterans Service Representative recruitment will be conducted next week.
- General Trainee Information: We have had four trainees in the program since 2015. One trainee resigned, one accepted a position with HHSA Public Authority, one is the current Senior Veteran Service Representative and one is the current General Trainee.

- Veterans from all eras are reacting to the events in Afghanistan, such as the U.S withdrawal and the takeover by the Taliban, and they may be reaching out for assistance. Veterans may question the meaning of their service or whether it was worth the sacrifices they made. They may feel more moral distress about experiences they had during their service.
- If U.S. citizens request help leaving Afghanistan, provide the information below:
  - The Embassy phone number is currently not operational. We continue to monitor for available phone numbers to provide to those needing assistance.
  - U.S. citizens seeking assistance to depart the country should complete the <u>Repatriation Assistance Request Form</u> for each traveler in their group. Spouses and minor children of U.S. citizens in Afghanistan who are awaiting immigrant Visas should also complete this form if they wish to depart.
    - Advise they should complete the form as quickly as possible and do so only once for each traveler.
    - Individuals must complete this form even if they have previously provided information to the U.S. Embassy in Kabul by other means.
    - This form is the only way to communicate interest in flight options. The State Department will notify individuals directly by email based on registration as soon as departure options become available. Do not travel

to the airport until you have been informed by email that departure options exist.

- All intending passengers should bring identity documentation to the best of their ability (U.S. passport, LPR card, even if expired).
- If an Afghanistan citizen has been employed by/on behalf of the U.S.
  Government, share this resource to receive information on how to apply for a special <u>Visa</u> for potential assistance to leave Afghanistan.
- To view the most up-to-date information on the situation in Afghanistan and potential assistance for evacuation for loved ones, visit <u>U.S. Embassy in</u> Afghanistan.

Veterans Memorial Building Council Report

Due to the fact that the VMB parking lot has been conscripted to serve as the incident command center of CalFire and the USFS, as well as the high AQI toxic smoky air and the increased risks posed by the Delta variant of COVID-19, we have decided to cancel the in-person September meeting of the EDC VMB Council.

We finally got reimbursed from the County for the "US Space Force" flag and flagpole we purchased (\$228.99) and the pole is in the rotation to be installed by the County. We are still waiting on reimbursement fo0r the 2021-2022 insurance policy. We had to renew the liquor license for the building after the County discovered that we need a license even to store alcoholic beverages in the building, whether we sell drinks or not. Treasurer Sweet renewed the license. I intend to send a letter to FRA Branch 275, VFW Post 10165 and VFW Post 2680 to share in reimbursing the cost to the Council, as they are the only organizations who keep a stock of alcoholic beverages in the building.

As you know, CalFire and USFS have taken over the parking lot. FRA Branch 275 and VFW Post 10165 have cancelled the Sunday breakfasts scheduled for 9/5 and 9/12. VFW Post 10165 is holding a "Executive Board" only meeting in lieu of their regular monthly meeting scheduled for 9/7/21. The "Dry Diggins" music festival scheduled for 8/27 and 8/28 was cancelled and moved to (appropriately) Grass Valley due to the Caldor fire, denying MCL and FRA a chance to make some money renting out the parking lot.

We are continuing to staff the building with a daily building manager from 8:00 AM until noon every day.

The building is still available to all organizations, veterans and otherwise, meeting there,according to the County, but the problem is access. The parking lot is usually quite full of fire related vehicles and traffic in and out is constant. I talked with the incident Commander for the Caldor fire a couple of days ago, and the best estimate that he could give me about when the Caldor fire would be considered under control was Monday, 9/13/21, but that is just an estimate. If and when the fire is declared controlled, it will take several more days to move the command center and all the related vehicles out of the parking lot, the Raley's lot next door and the fairgrounds itself.

I will keep everyone "in the loop" and inform all immediately when CalFire and USFS pulls out. Feel free to respond to this update or give me a shout with comments or questions.

Things keep changing, but this report was good on that day.

Evacuation

The south county four, and some Pollock.

"Do you know where Hundred is?"

Bird had just hauled him to court Monday, but Hundred was so doped up on pain meds, they put the matter over.

Unfortunately, they did not pick up a new cell phone, seeing as Hundred's cell phone was broken.

Then came the Caldor Fire.

Hundred lives Deep South side of Grizzly Flat. Mandatory evacuation. Hundred cannot drive, and can only hobble.

I called Marshall Hospital. Not a patient there. Called Tim Whalen of the Vet Center, who was working the Green Valley evacuation. Not there, but will ask the VA nurses to keep an eye out for him.

Asked Bird about two others in the red evacuation zone.

Pepsi is in full Marine mode working recon. On the ridge, monitoring the situation. Even though ordered out, holding his ground, until he sees the flames cross one more ridge.

Bird will take him in, even though he is in the yellow, warning zone.

Tyke, who just lost his father, a Vietnam Veteran, is not leaving either. Has a ton of animals. More than Animal Control can handle. His plan is to stay and water the animals, until he absolutely has to flee.

Figured he would choose his animals over his own safety.

Bird thinks he will save himself.

We'll see.

Walking on Broadway, and saw Jet's wife. I knew they had been evacuated, but you hate to bug people when they are in mid-crisis. She waved me down, and was glad to see me.

Told her about ALE. Additional living expenses. Homeowners insurance should cover evacuee's additional expenses. Like the motel stay they had just incurred.

Walking home, my brain cleared.

Call Hundred's girl friend.

As soon as I got in the house, Jet called.

"USAA says we are covered!"

Then called Hundred's friend.

She is a Pollock Pines evacuee staying with Camino Heights friends who are in the warning zone.

Told her about the ALE coverage, and the El Dorado Community Foundation fund for evacuees.

But she gave me the big news.

"Hundred is in the burn unit at UC Davis. His brother got him a new phone. Here is the number."

Called Chaplain Tim Thompson. Agreed that he would interface with UC Davis discharge planning and social workers.

Brought Bird up to speed.

He called Hundred's girl friend, to let her know he is part of the support team.

I left a message with JAG his public defender.

Let Tim Whalen know the story.

Reviewed our sequence for funding.

- 1. Insurance.
- 2. El Dorado Community Foundation Caldor fund.
- 3. Only Kindness, Rene Evans.
- 4. Volunteers of America, per Tim Whalen.
- 5. Military Family Support Group.

Hopefully, Jet's wife picked up a free bag of groceries for evacuees, at Placerville Food Coop, where she is a member.

We'll get through this.

Subj: Endorsement of EDC Veterans Monument Proposal

Dear Commissioners:

Thank you for placing the community supported proposal to recognize valor honorees at the El Dorado County Veterans Monument on this month's agenda. As an advisory commission on veterans affairs, this proposal falls within your responsibility and deserves your unanimous endorsement.

Enacting the proposal is in the public interest to recognize our nation's most highly decorated veterans. Regardless of their branch of service, or the length of their service to our country, they selflessly gave of themselves in service to their fellow veterans, to this community, and to the monument itself.

Master Sergeant William Cathcart is but one example of our County's veterans who have demonstrated selfless service and extraordinary heroism. He served in the U.S.

Marines during World War II, then in the U.S. Army during the Korean War and

Vietnam. In 1952, when the leader of an assaulting platoon was killed, Master Sergeant Cathcart rallied the platoon towards a well entrenched enemy position. He further braved enemy fire six times to rescue six wounded soldiers, demonstrating "utter fearlessness and completely selfless devotion to his men and his duty." For those acts Master Sergeant Cathcart was awarded the Distinguished Service Cross. He was also awarded the Bronze Star and Purple Heart medals, in addition to more than twenty other medals, awards and citations.

His military service continued in El Dorado County as a long-time active member of many local organizations, including American Legion Post 119, VFW Post 2680, the Marine Corps League, Legion of Valor, Disabled American Veterans, and Fleet Reserve Association. He committed himself to the monument as one of its founders and original "Friends of the Monument." Master Sergeant Cathcart is not alone in his devoted service to our Country, our County, and the County's Veterans Monument. Your endorsement of the proposal to recognize these distinguished veterans will fulfill an original purpose of the monument, for all those who will follow us to know their deeds. In this way, you will strengthen the monument's purpose as engraved in the main plaza: "To Honor Those Who Have Served the Cause of Freedom." As a matter of County policy, your endorsement would be consistent with both current policy and your advisory responsibilities. The monument may not be modified without County approval, as stated in the 2007 "Criteria for Military Honoraria and Civilian Recognition." It states, in part, "The County, through the General Services Department, will notify the Friends and the committee in writing of any proposed changes in the design, configuration, or landscaping of the monument. ... Private citizens, civic organizations, and military/veterans organizations are encouraged to communicate with the County and the Friends regarding proposed improvements and additions to the monument that are consistent with this policy."

As a fellow veteran I heartily urge you to unanimously recommend approval of the proposal to honor those veterans who have been recognized by the United States for valor, as recipients of a military service cross or the Medal of Honor. We are lucky to have so many among our County's veterans and should fulfill honoring them without delay.

The local community supports this proposal so much they have agreed to fund its

implementation. They have answered the call too, as they did in 2006 to fund the

monument itself. Please join them, the monument's founder, fellow veterans and family

members who support the monument's purpose becoming fully realized. In service,

# William D Cathcart



MASTER SERGEANT WILLIAM D. CATHCART, Infantry, United States Army. Sergeant Cathcart, a member of an infantry company, distinguished himself by extraordinary heroism in action against the enemy in the vicinity of Chungbangpíyong, Korea. On the morning of 18 February 1952, the company of which Sergeant Cathcart was a member was engaged in an attack against a large hostile force occupying a strategic and well-fortified hill. In the ensuing action, Sergeant Cathcart observed that the leader of the assaulting platoon had been killed and the friendly troops had been pinned down by the intense enemy fire. Without hesitation, he rushed to the men, rallied

them, and personally led them toward the crest of the hill only to be met by such a tremendous volume of fire that a withdrawal was necessary to save the friendly force from annihilation. Upon reaching the base of the slope, Sergeant Cathcart realized that several wounded were still on the fireswept hill. Without regard for his personal safety, he traveled back up the slope directly in the face of the heavy enemy fire to evacuate his stricken comrades. Six times, Sergeant Cathcart made his way almost to the edge of the enemy bunkers, and six times, he returned with a wounded man. Through his utter fearlessness and completely selfless devotion to his men and his duty, Sergeant Cathcart saved the lives of several of his comrades at great risk to his own. The extraordinary heroism display by Sergeant Cathcart on this occasion reflects the greatest credit on himself and is in keeping with the most esteemed traditions of the military service. Entered the Federal Service from California.

Mr. Cathcart passed away on 31 October 2017.

He was born on March 21, 1925 in Santa Ana, CA to William J. and Vera L. Cathcart. Rifle Company First Sergeant for 14 months and in the Republic of Vietnam, he was an Infantry Battalion advisor for 12 months. After retriring from the service, Bill worked as a security policeman for McDonnell Douglas loving and devoted wife, Margot Anne Cathcart; children Cynthia Bray and husband Richard, Rebecca Reynolds and husband Todd, and Robert Cathcart and wife Gina; grandchildren Nicholas and Austin (Bray), Julia and He and his wife Anne resided in Diamond Springs, CA. Bill served in both the Marine Corps from 1943 to 1945 and the Army from 1950 to 1968, and retired after twenty-three years of service with the rank volunteering as a speaker in the local high schools in the Placerville area and as an assistant for the football teams.
