 - Update to Annual Grants and Total 21/22 funding to the El Dorado Community Foundation for Mini-Grants (originally recommended in the 10/14/21 minutes and approved at the 11/18/21 meeting). The following chart is updated to reflect the change in awarded amounts to Folsom Lake College, who reported that they did not need funding this year. Additionally, the table shows the balance that will be awarded to the El Dorado Community Foundation to fund the mini-grant program. This amount is calculated by subtracting the total awarded amount from the Annual Grants (\$99,000) from the total amount of TOT funds allocated (\$175,000) for the 21/22 Fiscal Year. Commission voted 5-0 to approve the funding as specified in the table below.

Airporter can get Veterans from the SLT Casino area to the Reno Airport, and DAV provides shuttle service (by appointment) in the Reno area to the VA in Reno.

4. VA Updates:

Starting March 14, 2022 the VA will be transitioning fully into a hybrid work environment that blends in-person, telework and remote work. The VA recognized during the pandemic that leveraging technology and maximizing telework where feasible has helped the VA keep up with claim processing and providing outstanding service to veterans and their dependents.

The Board of Veteran Appeals:

Has learned that a limited number of Veterans may have had their BVA Form 10182 (Decision Review Request; Notice of Disagreement) mistakenly rejected for being untimely. If a claimant filed a VA Form between Feb 19, 2019 and Mar 23, 2021, and believes it may have been improperly rejected as untimely (within 1 year of decision) please send a letter to the "Clerk of the Board at P.O. Box 27063, Washington, DC 20038 or fax 1-844-678-8979 <u>No Later Than March 1,</u> <u>2022.</u> The letter should state that the claimant is asking the Board to <u>Recalculate Timeliness. Claimant should include Veteran's full name or</u> <u>SSN, the date of rating decision being appealed to the board, and the</u> <u>date of the original VA Form 10182 that the Board said is untimely.</u>

Oakland Regional Office:

The VA has appointed a new Director; Mr. Sergio Chao whom is currently the Director of the Honolulu VA Regional Office (VBA). Mr. Chao has a very motivating raise to his important roles in the VA. He's an Army veteran honorably discharged in 1996 and in 1998 he started his VA career in the mailroom at the Houston VA Regional Office as a work study, working his way through the ranks as Program Support, Budget Analyst, VSR and Rater in Comp and Pension, and so much other accomplishments. The Department of Veterans Affairs is planning to expand several programs that allow senior veterans to age in their homes or live in home-like settings

I've noted a few minor clarifications and added some information (highlighted below). Otherwise, you're synopsis is correct and I'm hopeful we can collaborate on some meaningful transportation solutions for the veterans in our community.

Matt,

Thank you for describing the services of the El Dorado County Transit Authority, as discussed today by phone. As mentioned, the El Dorado County Veterans Affairs Commission is concerned about the ability of veterans of the U.S. Armed Forces in getting to medical appointments at VA Medical Centers.

In particular, it seems that every week that passes our network of volunteers is tasked with helping an elderly, disabled or immobile veteran get from El Dorado County to an appointment at VA Medical Center Mather Field. The same occurs at South Lake Tahoe with transport to the VA in Reno.

Here's a recapitulation of what you described. Please correct me, if I've gotten any of this incorrectly:

- You did not recall anyone representing the veterans community having contacted you previously to discuss the issue of veterans transportation, but could not speak for your staff. I mention this only because it's clear that we the veterans community failed to inform the county transportation agency of our transportation needs. In talking to our Operations Manager who's been with us for much longer, our former Executive Director has been in communication with the Veteran's community in the past to explore partnership opportunities, but we've apparently never gotten to the point of implementation. He's not sure why, but assumes it was due to similar issues with staffing resources.
- El Dorado Transit now operates non-emergency medical transportation to medical facilities in Sacramento county on Tuesdays and Thursdays (only) for a

cost of \$10 to and \$10 from the medical facility. These rides can be scheduled up to four days in advance. These rides can be scheduled from at least four days in advance, up to fourteen days in advance.

- Your biggest constraint, currently, is the availability of staffing to operate this service. As such, you're investigating other ways of staffing transit services, such as reimbursing volunteers, though no decision has been made about such a method of providing transportation.
- Previously, you allowed scheduling up to 14 days, but the availability of staffing has limited how many days in advance transport may be arranged. We still allow scheduling up to fourteen days in advance, but the biggest consequence of being short staffed is on the general availability of rides. As it stands today, we only have a handful of vehicles in operation at any given time, and we just can't provide nearly as many rides as we were a couple of years ago.
- These Sac Med busses/vans depart from centralized transit centers and park and ride lots in: Placerville, Missouri Flat, Diamond Springs, Ponderosa Rd and El Dorado Hills. Dial-a-ride service to these departure locations can be scheduled from private residences.
- Return rides are scheduled at the same time that the initial ride to a medical facility is reserved, and El Dorado Transit is mindful that medical appointments might take longer than scheduled and accommodates such delays.
- El Dorado Transit welcomes further discussion on how it might assist the El Dorado County Veterans Affairs Commission and such volunteer organizations as El Dorado Veterans Resources and Military Family Support Group in transporting veterans to non-emergency VA appointments.

I hope that I've captured our discussion correctly. If not, please reply with any suggested changes, as I will be presenting this to the EDC Veterans Affairs Commission at its next meeting next Thursday in Somerset.

El Dorado Transit - SAC-MED

SAC-MED is a shared-ride, non-emergency, medical appointment, transportation service operated by the El Dorado County Transit Authority.

SAC-MED operates on Tuesdays and Thursdays <u>(only)</u> transporting passengers to medical appointments in the greater Sacramento area. Medical appointments must be scheduled between 10 a.m. and 2 p.m.

Registration Process and Application

Complete and return the Dial-A-Ride or ADA application to the El Dorado Transit office. <u>Dial-A-Ride Application PDF</u> <u>ADA Complementary Application Form</u>

Making a Reservation

SAC-MED rides must be scheduled at least four (4) but no more than fourteen (14) business days in advance by calling (530) 642-3696 between 9 a.m. and 5 p.m. Ride requests are accepted on a first come/first served basis.

If passengers need assistance, they must provide a Personal Care Attendant (PCA) and include such information when making the reservation.

Passengers receive a confirmation call back by 4 p.m. the day before the scheduled trip to confirm the exact pickup location and time.

Pickup and Drop Off Locations

SAC-MED is a flexible service that transports passengers directly to the curb of their destination in the greater Sacramento area.

SAC-MED pick-up and drop-off locations in El Dorado County are:

- Placerville Station (Mosquito Road)
- Missouri Flat Transfer Center (near WalMart)
- Central Transit Center (Diamond Springs)
- Ponderosa Road (Wild Chaparral) Park and Ride
- El Dorado Hills Park and Ride

To get to and from pick-up and drop-off locations, schedule separate Dial-A-Ride trips.

Fare

The fare for SAC-MED is \$10 each way. PCAs travel at no charge.

Guests: David Zelinsky phoned in before the meeting and announced that Kirkwood Mountain Resort was offering free day passes for snowshoe and cross-country skiing, including equipment, for all veterans. No reservation required, just show up and show veterans I.D. We also were introduced to the new EDC VSO, Terry Thomas, who came to us from his last assignment in Santa Clara and is a USMC veteran. More from Mr. Thomas in the Veterans Service Office report.

Chairman McAdams opened the business meeting with the flag salute and pledge of allegiance at 6:20 PM with 11 total in attendance. All officers were present and all organizations represented. The minutes of the 1/6/21 meeting were accepted as published on a motion by Allen Amaro and a second by Trustee Mansfield. The Treasurer's report was accepted as presented by Treasurer Sweet, subject to audit, on a motion by Secretary Sauvé and a second by Trustee Young.

<u>Building Manager's Report</u>: Dave Sauvé mentioned that in the last few days the Placerville Garden Club, along with volunteers from VFW Post 10165, had done a landscaping/beautification/cleanup of the area along Armory Drive and that the dumpster enclosure had been cleaned out. He reported that Pro-Line Custodial Service had been doing a much improved job cleaning the building since his letter to them last month, and he handed out info on a grant program involving funds from the American Rescue Plan Act via El Dorado County for local non-profits who suffered revenue loss due to the Covid-19 restrictions over the last two years.

<u>Veterans Service Office report</u>: New County VSO Terry Thomas gave us an extensive report on the workings, needs and goals of the EDC Veterans Service Office. Included in his presentation were facts and figures on how many cases our local office handled in the last year (854 phone consultations, 844 appointments, 1276 walk-ins, etc.) and the fact that at this point the staff is short-handed. They are seeking candidates for a Veterans Service Representative. He reminded us of the working hours and days of the week options for walk-ins and appointment procedures. South Lake Tahoe office is now active and open on a limited basis. He is making accountability of staff members a priority.

No unfinished or new business offered up for discussion

<u>"Good of the Council,"</u> Tim Whalen of EDVR/MFSG let us know that there are various mobility assistance devices available from his group. Treasurer Sweet would like a meeting with Leo Cooper of "Feed our Vets" to discuss kitchen and storage use. We will set one up for next Thursday. Secretary Sauvé moved to adjourn, Allen Amaro seconded and Chairman McAdams adjourned the meeting at 6:38 PM after a final flag salute. Next meeting is Thursday, March 1st, 2022.

Married. Kid on the way. New home. 100% service connected. Drug and Alcohol counselor. Wants to help his fellow Veterans.

Middle:

"I want someone from the VA to be at our house meeting to advocate for us Veterans."

I gave him the name and phone contact.

I cautioned him that clients are always fighting over rules and restrictions when they are in a recovery program.

"That's not it. I do not want to go to another place. I just want this place to do better, to be as good as it is capable of being."

He might make it.

Beginning:

Why is he still in custody? I thought he was all set to be transferred to treatment.

"The D.A. is going for a felony this time, not a misdemeanor."

If the Vet flunks out of his recovery program, he will be a convicted felon, and on his way to state prison. His success record is abysmal.

Still, with that hammer hanging over his head it might be the motivation he needs to succeed.

He has no choice.

Subj: For the Good of the Order

The agenda item, "Good of the Order," generally refers to "that portion of the agenda or meeting during which members may make statements or offer observations about the character or work of the organization without having any particular item of business before the meeting." It is "also the time to offer a resolution to bring a disciplinary charge against a member for offenses committed outside of a meeting."

The enclosed information is submitted as public comment for your consideration. In summary, the chairperson's previous claims that commissioner Cockrell "has no affiliation with the Proud Boys and never has" or "[he] has no connection to them at all" were not accurate then, nor are they now.

Commissioner Cockrell has a link with the Hangtown Proud Boys that existed prior to his January, 2021 nomination. He has other friendships with people and groups who openly support Proud Boys and neo-Nazis, and is friends with a Proud Boy who participated in that group's attack of the U.S. Capitol on January 6, 2021.

Since last February I have urged the commission to responsibly address these issues, with multiple opportunities for any commissioner to respond. Instead, you sought to deny my right to public comment in court, attacked me in private, and chose to remain mute in public.

I urge you again to face the facts of an inappropriate relationship that is counter to the core values of our Armed Services and to the oath we all took to defend our country from all enemies, including the domestic ones who conspired to end our nation's historical legacy of a peaceful transfer of elected power.

INTRODUCTION

On February 9, 2021 the El Dorado County Board of Supervisors ("Board") voted 4-1 to approve the nomination of Mr. Chris Cockrell ("Cockrell") to the County's Veteran Affairs Commission. Cockrell, a U.S. Army veteran, was nominated by newly elected Supervisor George Turnboo.

Cockrell's nomination was strongly opposed for questionable associations with the Proud Boys organization, including a newly formed chapter known as the "Hangtown Proud Boys" ("HPB"). The group's logo includes a body hanging by a noose from a large tree, as shown on the cover of this review. Opponents also took note of Cockrell's social media posts disparaging those he identified as "Democrats" or "Progressives."

The chairperson of the Veteran Affairs Commission, John Poimiroo ("Poimiroo"), repeatedly denied that Cockrell had any relationship with the Proud Boys. For example, Poimiroo told the Board on February 9, 2021 that Cockrell "had no relationship with Proud Boys, he was not a member and had no association. He didn't know them. ... He has no connection to them at all."

For his part, Cockrell never addressed the substance of the Proud Boys before the Board. On January 5, 2021 he simply said, "I deny any of the accusations that had been communicated." On February 9, 2021 he said, "There's not one substantiated allegation by any of these in writing, that are slandering me, that can be proven true," adding, "we need to step aside from the political attacks."

The facts in this review cast doubt on Poimiroo and Cockrell's unsupported denials. They show that prior to Cockrell's nomination he had an undisclosed link to the HPB President, was following the HPB on Parler, and had other undisclosed connections to Proud Boys supporters.

Following his appointment Cockrell befriended an avid supporter of the Proud Boys who also supports neo-Nazis, has maintained a link to the HPB President, and befriended a Proud Boy who participated in the January 6, 2021 attack upon the U.S. Capitol.

COCKRELL'S PRE-NOMINATION EXTREMIST LINKS

The Proud Boys in 2020 were described by the Anti-Defamation League as "an unconventional strain of American right-wing extremism. ... In reality, the Proud Boys bear many of the hallmarks of a gang, and its members have taken part in multiple acts of brutal violence and intimidation."

The most notorious act of Proud Boys violence was their attack of the U.S. Capitol on January 6, 2021. Joseph Biggs, a U.S. Army veteran and Proud Boy from Florida, led a nationwide group of Proud Boys from the Washington Monument around the Capitol, then facilitated the first breach of the Capitol grounds. Another Proud Boy and veteran, Dominic Pezzola of New York, used a stolen police shield to first breach the Capitol building itself, allowing hordes of rioters including Biggs, to follow inside.

A. PARLER ACCOUNTS

Cockrell submitted an application for the veteran affairs commission in January, 2021 and was appointed by the Board on February 9, 2021.

Five days after the November 3, 2020 U.S. Presidential election, Cockrell established an account on Parler.² At that time the Anti-Defamation League said, " "Parler has attracted a range of right-wing extremists" including Proud Boys; proponents of the QAnon conspiracy theory; anti-government extremists including members of the Oath Keepers, Three Percenters, and other militia groups; and white supremacists including members of the alt-right and accelerationists such as the terrorist group Atomwaffen Division."³

Since the U.S. Capitol attack, multiple Proud Boys have been arrested and charged with conspiracy and obstruction of Congress, including Biggs and Pezzola. The leader of the Oath Keepers, Stewart Rhodes, and ten others have been arrested and charged with seditious conspiracy.⁴

Among those group's members were two Proud Boys who participated in the U.S. Capitol attack, Gernaro Nunez of the Connecticut chapter, and Dallas Davis, President of the Helena chapter.⁸






B. DECEMBER, 2020 TOYS FOR TOTS EVENT

On December 5, 2020 the HPB, along with members of the "State of Jefferson Proud Boys" donated toys at a downtown Placerville Toys for Tots event, then posed for group photos along with Cockrell, who joined in flashing the group's divisive "OK" sign.

Cockrell was distinctively dressed in Santa Claus attire, claimed to have been invited by the event organizers, and posed for photos in front of and behind the Proud Boys group.⁹

Three members of the Proud Boys group later proclaimed to the Placerville City Council that they were former Marines.



On December 8, 2020 the local Toys for Tots organization disavowed the Proud Boys gathering, saying, "It is unfortunate that while we were conducting our drive-thru donation event, that others chose to use our event to further their own political or personal agenda. ... The mission of collecting and distributing new, unwrapped toys to our Nation's most precious resource – its children – is carried out by tens of thousands of Marines, sailors, and volunteers who adhere to the Core Values of our Corps – Honor, Courage, and Commitment. By doing so, we provide that beacon of hope to millions of children. ... We have no affiliation with the Proud Boys."¹¹

On February 12, 2021 Poimiroo publicly defended Cockrell in a Mountain Democrat article. In response to community criticism of Cockrell and the Proud Boys, Poimiroo "called the accusations "absolutely without merit. The best way to describe them is as patently untrue, libelous and a disturbing effort at character assassination. Chris has no affiliation with the Proud Boys and never has. He was invited by Toys for Tots ... to portray Santa Claus at their Toys for Tots event in Placerville."¹²

The same article noted, "The Marine Corps League SSgt. Sky Mote Detachment No. 697 issued a statement clarifying that Cockrell was not the official Santa Claus invited by Toys for Tots organizers or the Marine Corps League to participate in the Dec. 5 Toys for Tots collection event."¹³

On February 13, 2021 the local Toys for Tots organization issued a Facebook statement that read, "Unfortunately it appears we must address this again as *no one from the veterans commission* nor the media have contacted us on this issue. Please see below announcement from the Placerville MCL and our post from December 6th *with our authorized Toys for Tots Santa* and the Mrs who were following Covid 19 guidelines during our December 6th event. Thank you."¹⁴ (emphasis added.)

It's obvious to many of us who follow local politics that Chris Cockrell aligns himself with the local Proud Boy hate groups. Here is the clear linkage.

There is a local man named Aaron Bate who consistently rallies Proud Boys, Bikers, and III%'ers with the same messages of hate. He was a primary instigator in the violence that occurred with the BLM protests in Placerville, and also runs the Facebook Page AJ Boots which is his group called "Boots on the Ground". Chris Cockrell can be seen "liking" posts in which these members are flashing the "White Power" sign. If you go to AJ Boots Facebook page and look at the January 1st photo of Bates and a woman flashing a White Power hand sign, you will see that Cockrell has "liked" the photo.

Cockrell has no business in gaining any role of influence in your town.














Cockrell Facebook post with "Like" by "Bon Bon" Dec. 16, 2020



Kiehl is the President of the HPB chapter; previously he was the chapter President of the Sacramento Proud Boys, alongside Proud Boys Marcos Santos, identified above as one of the Proud Boys to attack the U.S. Capitol on Jan. 6, 2021.

Patrick George Kiehl is the president of the Placerville <u>"Hangtown"</u> Proud Boys. He owns Liberty Handyman LLC, and currently lives in Pollock Pines with his wife Bonnie Mae. He was also active in the NorCal punk/hardcore music scene in the early 2000's. Kiehl has been involved with Proud Boys in the Northern California area since at least 2018, and has been connected to numerous far-right extremist actions and events since then. This article offers an overview of the Proud Boys as an organization, a timeline of Kiehl's activity, information on the Hangtown Proud Boys chapter, and Kiehl's personal details/identifying information.



Poimiroo dismissed Cockrell's participation with the Proud Boys at the Toys for Tots event in a Sacramento Bee article, among other public denials published by the Mountain Democrat newspaper and KOVR, a Sacramento CBS affiliate.²¹

VETERANS AFFAIRS COMMISSION MEMBERS WEIGH IN

Poimiroo, of the Veterans Affairs Commission, said during Tuesday's public comment period that he and a colleague undertook "an investigation of what happened with Proud Boys" and determined it to be a misunderstanding, as Turnboo had written.

"He was there in Placerville simply to portray Santa Claus," Poimiroo said. "He has read conservative sites, he has looked to see who they are, but he has no association with them. And to be maligned and mischaracterized as being a supporter of Proud Boys is absolutely false. He has no connection to them at all."

Poimiroo called Cockrell "very conservative" but not hateful.



COCKRELL'S ATTEMPTS TO REMOVE EXTREMIST LINKS

In response to public criticism of his contentious nomination Cockrell demonstrated a habit of attempting to hide information that was criticized. For example, on January 6, 2021, just one hour and five minutes after the Board was notified of Cockrell's links to Bate, Cockrell removed himself from that link.²³

After public criticism of his public Facebook posts, the Board was notified before its appointment vote that Cockrell had removed all but three posts, one of them being the saluting Santa image liked by "Bon Bon."²⁴

Communications and Character: My January 4th letter described Mr. Cockrell's open disparagement of "Progressives" and "Democrats" on his Facebook accounts. As of today (Feb. 3, 2021), Mr. Cockrell's Facebook account has been scrubbed clean (or publicly blocked) of those views. His public page has only three administrative posts: (1) a 2017 update of his biography, which simply lists his business name and address; (2) a December, 2020 cover photo update of a Santa dressed in American flag attire, saluting an American flag; and (3) a January 15, 2021 cover photo update showing a field of American flags and the line "Freedom isn't Free." COCKRELL'S POST-APPOINTMENT EXTREMIST LINKS

As highlighted above, Cockrell has retained previously undisclosed links to Bate, Kiehl, and the HPB, who each have their own extremist links.

One of those extended links is to Linda Hanna ("Hanna"), an El Dorado Hills woman with her own extensive ties to extremists, including Proud Boys, neo-Nazis, and a Proud Boy who participated in that group's January 6, 2021 attack of the U.S. Capitol. Hanna is an activist with "Latinos for Trump" and attended political rallies in Washington, DC, including on Jan. 6th.²⁵ It is not known if Hanna was at the U.S. Capitol, but friends of hers are publicly documented as being on the Capitol grounds.

Hanna and her husband, Greg, an Army veteran, are also active members of the "New California" movement, which advocates for forming a new State from the State of California.²⁶



Furthermore, there is no record of Cockrell publicly acknowledging his Parler account, or how long he may have continued to use it after his 2021 appointment. His Parler posts included anti-government views as illustrated below. Cockrell's Parler account listed "1Surfaben" as being followed by Cockrell.

A. LINDA MARTINEZ HANNA – PROUD BOYS / NEO-NAZI LINKS

Hanna and Cockrell have been openly linked on social media accounts since at least May, 2021, and are mutually linked to Aaron Bate and a Proud Boy who participated in attacking the U.S. Capitol. Cockrell has retained his link to Hanna as of February, 2022.






In June, 2021 I showed the veteran affairs commission some photos of Cockrell and the Proud Boys attending Hanna's party. Cockrell was not present at that meeting.














PART II PREVIEW: ATTACK OF THE U.S. CAPITOL LINKS

The most significant impact of the extremist links summarized above is the eventual attack of the U.S. Capitol on January 6, 2021. Cockrell and Hanna each have a direct link to a Proud Boy who participated in that attack. That Proud Boy describes themself as the son of a veteran.

The details of the Proud Boys attack on the U.S. Capitol are too lengthy to include here but will be described in full, showing Cockrell and Hanna's links, who was involved in the attack, and how the Proud Boys literally led the first breach of the Capitol grounds and the Capitol building.

CONCLUSION

Cockrell and Poimiroo's unsubstantiated denials of links to the Proud Boys were not supported then, nor are they now. There is no daylight between Cockrell and the attack of our nation's Capitol, and there is no daylight between Cockrell and the commission, whose members have remained mute about these links for a year now. None of this is befitting the core values of our Armed Forces, the oath all military members take to support and defend the U.S. Constitution, or the County's integrity.
