Project Description: Mobile Integrated Support Services (MISS) The Mobile Integrated Support Services (MISS) initiative is a dynamic, community-centered outreach program aimed at addressing the critical needs of unhoused veterans and vulnerable populations throughout El Dorado County. Through a mobile service delivery model, MISS brings vital wrap-around services directly to veterans who often face significant barriers in accessing traditional care and support systems. MISS is designed to bridge service gaps by offering coordinated care that includes mental health and substance use support, medical and behavioral health assessments, housing navigation, benefits enrollment assistance, peer support, and connections to long-term case management. By leveraging partnerships with local healthcare providers, veteran organizations, veteran court, and housing services, MISS operates as a seamless network of support delivered where it's needed most—in the community. We already have a unit in place for Sacramento County and it is a huge success with multi-year funding.

Geographic Area Served by this Grant	Placerville and surrounding communities in El Dorado County. This area strikes a balance between need and access. Placerville has a higher population density compared to eastern parts and can serve as the hub for services and outreach. Highway 50 corridor from Folsom, to El Dorado Hills through to Placerville are more reachable due to proximity to main transportation route.
What is the need that your project/program that you are requesting funds for supports?	

Community Need & Potential Impact - El Dorado County has seen a concerning rise in homelessness, particularly among veterans who face unique challenges such as PTSD, physical disabilities, and difficulty accessing VA services. Many individuals experiencing homelessness in rural areas encounter transportation barriers, fragmented care, and a lack of local resources. Traditional service models often fail to reach those living in isolation or moving between temporary encampments. MISS directly addresses these challenges by meeting individuals where they are—literally. The mobile outreach team travels throughout the county, including remote and underserved regions, ensuring that support is accessible to more veterans. This approach reduces service fragmentation, increases engagement, and improves outcomes by building trust and continuity of care. Since its launch in the Sacramento County area in 2020, Jake's Journey Home's MISS Program has demonstrated success in reducing emergency room visits, facilitating housing placements, and re-establishing connections between veterans and VA benefits. Our person-centered, trauma-informed model not only meets immediate survival needs but also lays the groundwork for long-term stability and self-sufficiency.

El Dorado County is home to approximately 17,000 veterans (U.S. Census Bureau, American Community Survey 2023). Veterans make up about 9% of the county's adult population, higher than the California state average (~5.5%).

Health Needs - According to VA data: 26% of El Dorado County veterans report service-connected disabilities. Top reported issues include PTSD, depression, chronic pain, and mobility impairments.

Mental health: El Dorado County veterans experience higher rates of suicide risk compared to the general population.

Housing and Homelessness - El Dorado Continuum of Care 2023 Report found: At least 7% of the county's homeless population are veterans. Veterans are more likely to face chronic homelessness due to mental health issues, addiction, and lack of support networks.

Employment and Income - Veterans in El Dorado County have a higher unemployment rate (around 6%) compared to the civilian population (about 4.2%). Those with disabilities have much lower workforce participation. Many veterans struggle with job retraining, credentialing barriers, and access to stable employment.

Education and Training Needs - Around 32% of El Dorado County veterans do not have post-secondary education (U.S. Census ACS 2023). There's significant need for vocational rehabilitation, job skills programs, and GI Bill navigation help.

Higher-than-average veteran population for the region. Critical gaps in mental health support, housing assistance, employment training, and healthcare access. Federal and state services are present but under-resourced locally - a program like Jake's Journey Home MISS could directly fill service gaps and coordinate care more effectively.

How will this program/project in this grant request address the need described above?

The **MISS (Mobile Integrated Support Services) program** is specifically designed to close critical gaps in care and services for veterans living in El Dorado County. By utilizing mobile, community-based outreach teams, the MISS program will bring essential services directly to veterans where they live.

MISS will address the identified needs in the following ways:

Access to Healthcare and Behavioral Health Services:

MISS teams will provide direct connections to healthcare providers, mental health professionals, and case management. This will reduce barriers like travel distance, VA wait times, and system complexity.

Housing Stability Services:The program will identify at-risk veterans and connect them to housing resources, eviction prevention programs, and VA housing assistance programs (HUD-VASH, SSVF).

Behavioral Health and Suicide Prevention:By providing mental health screenings, crisis intervention, and peer support services, MISS will directly respond to the high rates of PTSD, depression, and suicide among veterans.

Personalized Case Management:Each veteran contacted through MISS will receive a customized action plan, ensuring a "no wrong door" approach to accessing VA benefits, local social services, or specialized care.

Community Reconnection and Outreach:Regular visits with isolated veterans will rebuild trust, reduce isolation, and help veterans reintegrate into the broader community. In short, MISS will help to create systems to alleviate navigation barriers — ensuring that no veteran in El Dorado County is left behind because of geography, age, disability, or lack of information.

We are uniquely positioned to meet the needs of local veterans because: Experience and Expertise: Our volunteer staff includes veterans, military family members, and professionals with years of experience working within VA systems, housing programs, behavioral health services, outreach. Community-Based Approach: We prioritize "meeting veterans where they are" — both physically and emotionally — by offering mobile services, personalized case management, and strong community partnerships. Established Partnerships: We have developed strong working relationships with VA offices, housing authorities, behavioral health providers, workforce development agencies, Courts & Law Enforcement. Our program has an understanding of the unique challenges veterans face, including transportation barriers, geographic isolation, and limited access to care. Funding this MISS program will allow us to directly implement a veteran-centered, trauma-informed model that aligns with our organizational mission. By providing flexible, mobile, and community-driven services, helping close critical service gaps and ensure that every veteran has a chance to thrive and succeed.

Measurable Objectives for the MISS Program Outreach:
Contact as many veterans as possible across El Dorado County within 12 months.
Enrollment: Complete needs assessments and enroll as many willing veterans as possible into some services (basic needs, mental health etc.)
Housing Support: Help veterans at risk of homelessness access stable housing resources.
Mental Health Connections: Refer veterans to mental health or behavioral health services.
Transportation Assistance: Help/Educate veterans on accessing transportation supports.
Reporting: Submit final reports to track outcomes and program impact.

How will the objectives be measured?

Objectives will be measured through outreach logs, completed intake forms, housing and service referral records, transportation assistance logs, client satisfaction surveys, and quarterly progress reports. Data will be collected and reviewed monthly to track progress toward goals.

What is the anticipated impact of the project?

Anticipated Impact
The Jake's Journey Home - MISS program will improve access to healthcare, housing, and basic support services for most veterans we meet and hopefully at least 35 veterans in El Dorado County, reducing isolation, increasing stability, and improving overall quality of life for veterans in rural and underserved areas.

How will you measure the impact of this project/program?

We will measure impact by tracking the number of veterans served, services accessed (housing, healthcare, transportation), improvements in client outcomes through follow-up assessments, and client satisfaction survey results, along with analyzing data in quarterly and final evaluation reports.

What determines if your program/project continues on in regards to impact?

Ongoing Nature of the Program and Future Funding Plans: Jake's Journey Home MOBILE Outreach has been in existence for over 5 years and is designed to be an ongoing initiative. Upon completion of this grant cycle, we will seek continued funding through a combination of government grants (federal and state-level), local fundraising efforts, and partnerships with veteran-focused organizations. Additionally, we plan to explore private sector sponsorships and individual donations to ensure long-term sustainability.
