EL DORADO COUNTY SEPTAGE HAULERS INSURANCE REQUIREMENTS EFFECTIVE 1/1/2002

Permittee shall maintain, at Permittee's own expense during the term hereof, insurance with respect to Permittee's (business, the premises and all activities, on or about or in connection with the premises) of the types and in the minimum amounts described generally as follows:

- A. Full Worker's Compensation and Employers' Liability Insurance covering all employees of Permittee as required by law in the State of California.
- B. Comprehensive Public Liability Insurance or Comprehensive Liability Insurance (Bodily Injury and Property Damage) of not less than One Million Dollars (\$1,000,000) combined single limit per occurrence, including but not limited to endorsements for the following coverages: personal injury; premises-operations; blanket contractual; and independent contractors liability.
- C. Comprehensive Automobile Liability Insurance (Bodily Injury and Property Damages) on owned, hired, leased and nonowned vehicles used in connection with Permittee's business of not less than One Million Dollars (\$1,000,000) combines single limit per occurrence.

<u>Additional Insureds:</u> The insurance required under B and C above shall include the County of El Dorado, its officers and employees and each of them, as additional insureds except with regard to occurrences that are the result of their sole negligence.

<u>Primary Coverage:</u> The insurance required under B and C above shall provide that it is primary coverage with respect to Permittee, the County of El Dorado, and all other additional insureds.

<u>Cancellation Notice</u>: The insurance required above shall provide that no cancellation or material change in any policy shall become effective except upon thirty (30) days prior written notice to the County of El Dorado at the office of the El Dorado County Risk Manager, 330 Fair Lane, Placerville, CA 95667.

<u>Premium Payments:</u> The insurance companies shall have no recourse against the County of El Dorado, its officers and employees or any of them for payment of any premiums or assessments under any policy issued by a mutual insurance company.

<u>Proof of Insurance Requirements:</u> Permittee shall furnish proof of coverage satisfactory to the El Dorado County Risk Manager as evidence that the insurance required above is being maintained.

Policy Deductibles: Permittee shall be responsible for all deductibles in all of Permittee's

insurance policies. The amount of deductibles for an insurance coverage required herein shall be reasonable and subject to County's approval.

<u>Permittee Obligations:</u> Permittee's indemnity and other obligations shall not be limited by the foregoing insurance requirements and shall survive the expiration of the permit.

<u>Material Breach:</u> Failure of Permittee to maintain the insurance required by this paragraph, or to comply with any of the requirements of this paragraph, shall constitute a material breach of the entire permit.

<u>Commencement of Performance</u>: Permittee shall not commence performance of this contract unless and until compliance with each and every requirement of this paragraph is achieved.

<u>Claims Made Insurance:</u> In the event Permittee cannot provide an occurrence policy, Permittee shall provide insurance covering claims made as a result of performance of this contract for not less than three (3) years following completion of performance of the permit.
