State Law requires any process that emits or has the potential to emit air contaminants obtain an Air Pollution Permit from the local Air Pollution Control District or Air Quality Management District.



Air Permits are typically required for the following small businesses:

- Dry Cleaners
- Most Gasoline Dispensing Operations
- Auto Body and Repair Shops
- Surface Coating Operations
- Printing Operations

Air Permits are typically required for these equipment & processes:

- Equipment that has a stack, dust collector or vent
 - Abrasive blasting, fuel or chemical tanks.
- Processes using paints, solvents, adhesives, or inks
 - Paint booths, printing presses, and solvent tanks
- Processes that burn fuels
 - Boilers, furnaces, internal combustion engines, generators
- Processes that produce visible smoke, dust, or odors
 - Abrasive blasters, incinerators, grain handling

Air permits are typically required in the following situations:

- **Before** installation of new equipment
- **Before** modifying existing equipment
- When a business changes name or ownership
- **Before** equipment is transferred from one location to another
