#### **IRREVOCABLE OFFER OF DEDICATION (IOD) PROCESS**

#### **PURPOSE:**

An Irrevocable Offer of Dedication is necessary when a property owner is required as a condition of approval for a discretionary project (i.e., Special Use Permit, Certificate of Compliance, etc.) to dedicate a road right of way in fee, or an easement to the County of El Dorado. These easements may include, but are not limited to, public utilities, road right of ways, drainage, slope or landscaping.

#### **AUTHORITY:**

The authority to invoke the process of dedicating real property or easements over, under and/or across property by the County is established under Section 7050 (c) of the California Government Code and Sections 66475 and 66477 of the Subdivision Map Act. The Board of Supervisors, at their discretion, can accept, reject, or accept subject to improvement, any offer of dedication for the required dedication of any real property or easements.

#### PROCESS:

The applicant petitions the County of El Dorado Board of Supervisors through the County Surveyor's Office, to accept, acknowledge but reject or accept subject to improvements, the Offer of Dedication.

#### PROCEDURE INITIATED BY THE PROPERTY OWNER OR THEIR AUTHORIZED REPRESENTATIVE:

- 1. Prior to completing the Irrevocable Offer of Dedication (IOD) application, the owner provides the County Surveyor with an exhibit clearly depicting the area to be dedicated. The Surveyor's Office will verify its authority to assist the owner with the dedication and advise the applicant on the process necessary to go forward. If it is determined that the County Surveyor's Office has the authority to process the dedication, the owner will receive notice to proceed with the IOD Application.
- 2. When the notice to proceed is received, the completed IOD application signed by the property owner may be submitted. A separate application for each Assessor's Parcel Number (APN) held in separate ownership shall be required. The application must include all required materials including a deposit of \$434.00 per parcel. Checks should be made payable to the County of El Dorado. For multiple parcels under common ownership, contact the County Surveyor's Office for fee information.
- 3. The County Surveyor's staff reviews the completed application for accuracy and conformity with State law and local ordinance. Upon verification that all necessary approvals, materials and exhibits are in order, the staff prepares an agenda package for the Board of Supervisors (BOS) which includes the IOD bearing the owner's notarized signature for the Board to approve and adopt, subject to any conditions they may establish.
- 4. On the day of the board meeting, the agenda package will be presented to the Board of Supervisors for their determination. This meeting is a public meeting open to public comment and the owner may choose to attend or send a representative. If the Board accepts the dedication, the Board Chair will sign the document acknowledging the offer. The dedication is complete when the Board Clerk records the IOD with the County Recorder.

5. The Irrevocable Offer of Dedication process generally takes eight to sixteen weeks after the applicant has submitted a complete application package. The processing time varies depending on the complexity of the dedication.

## IRREVOCABLE OFFER OF DEDICATION (IOD) APPLICATION

The Irrevocable Offer of Dedication (IOD) process may take eight to sixteen weeks after the applicant has turned in a **completed** application. A completed application includes the *Application Deposit* and all supporting documents listed under the *Required Materials* section. The processing time may be extended if any of the required materials submitted are found to require further review. Application expires one (1) year after date of submission. Applicant may apply for an extension. Fees may apply.
