



RESOLUTION NO.
OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

TAHOE TRUCKEE DISPOSAL CO., INC., dba
TAHOE TRUCKEE SIERRA DISPOSAL

WHEREAS, a public hearing was held on June 23, 2026, for the purpose of adjusting solid waste collection rates in the Tahoe Truckee Disposal Co., Inc., dba Tahoe Truckee Sierra Disposal, Tahoe-Emerald Bay Franchise Area; and

WHEREAS, County Ordinance section 8.42.150 provides that the Board of Supervisors shall set the rates to be charged by a franchisee at such time as the Board deems appropriate; and

WHEREAS, pursuant to County Ordinance section 8.42.170, the franchisee has provided written notice to each ratepayer of the proposed adjustment in a form approved by the County of the time, date, and place of the public hearing to set rates and the notice was provided at least ten but no more than sixty days before the public hearing; and

WHEREAS, pursuant to County Ordinance section 8.42.180, the County provided a written notice, at least 45 days prior to the hearing, to the record owner of each parcel subject to the franchise service in the areas defined in Section 8.42.200. The notice included a description of the proposed rate adjustment, including the maximum proposed rates; the basis and purpose of the adjustments; the date, time, and location of the public hearing; a clear statement advising that written protests may be submitted and shall include the parcel address or Assessor's Parcel Number (APN); The protester's name and signature; a statement of opposition; and the declaration whether the protester is a property owner or utility customer.

NOW, THEREFORE, be it resolved that for the 2026 Interim Year, effective July 1, 2026, the following rates are adjusted upward by six percent (6%) for the collection of solid waste within the Tahoe Truckee Sierra Disposal franchise area:
