## Plan Review Submittal

### NON - RESIDENTIAL NEW BUILDING

**The following items are required to be a deemed complete permit application**

#### **TWO complete sets of WET STAMPED plans that include:**

- COVER SHEET & PROJECT LETTER
- SITE PLAN & LANDSCAPE PLANS with complete square foot summary of [impervious](#) surface coverage. (Ctrl + click on word impervious for definition)
- CALGREEN NON RESIDENTIAL CHECKLIST (Link to: [2016 CALGREEN CHECKLIST](#))
- POST CONSTRUCTION STORM WATER CONTROL PLAN – (if applicable)  
(Link to: [Storm Water Management Info](#))
- MWELo CHECKLIST (Link to: [MWELo Submittal Form](#))
- FLOOR PLANS (dimensions and drawn to scale)
- EXTERIOR ELEVATIONS
- FOUNDATION PLANS
- FLOOR FRAMING PLAN – (if applicable)
- ROOF FRAMING PLAN – (with wet stamped truss calcs if applicable)
- ENGINEER CALCS
- CURRENT SOILS REPORT
- ELECTRICAL PLAN – (Must be prepared by and architect, engineer, or a licensed installer)
- PLUMBING PLAN – (Must be prepared by and architect, engineer, or a licensed installer)
- MECHANICAL PLAN – (Must be prepared by and architect, engineer, or a licensed installer)
- CALIFORNIA ENERGY LOSS REPORT (TITLE 24)
- APPLICATION FEE

#### **PLEASE NOTE:**

- A separate commercial grading permit will be required.
- One additional floor plan is needed before permit issuance.
- Applicant submits to the applicable fire department separately.
- Applicant secures all necessary approvals from outside agencies.

*I understand and application missing any items will be deemed incomplete and the plan check will not be scheduled until all the items above are received by Building Services. This may affect applicable fees and codes, since the operative date of application will be the date on which a complete application is received.*
