- Weight Limit Restriction Survey on North Upper Truckee Road and Lake Tahoe
   Boulevard: The weight limit restriction will include North Upper Truckee from Hwy 50 to
   Lake Tahoe Boulevard and continuing to Sawmill Road.
   Staff recommends adopting a 7 TON restriction and enforced by California Highway Patrol
- 2. Amend EDC Ordinance 10.12.184 Lake Tahoe Watershed Area, Parking Restrictions during snow removal season:

Staff recommends amending El Dorado County Ordinance 10.12.184, creating consistency between West Shore and South Lake Tahoe snow removal signs.

Signs shall read: "No Parking on Roadways or Shoulders Nov. 1 to May 1. Violators Subject to Fines and Tow-Away"
